

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.hoaextensions.com, and House of Alexandria Luxurious Extensions and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to House of Alexandria Luxurious Extensions include www.hoaextensions.com, HOA Extensions and HOA Exten. The HOA Extensions website is a Hair extensions supplier site. By using the HOA Extensions website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, HOA Extensions may collect personally identifiable information, such as your:

- - First and Last Name
- - Mailing Address
- - E-mail Address
- - Phone Number

If you purchase HOA Extensions's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.
